- 3. Public Question Time
 Applicant for PA23/04972 outlined the background to the land in question and details of the application.

A resident from Brookside informed the Council on issues such as poor maintenance, its general condition, key management for spaces like the community Room, which residents no longer use. Fire Alarms constantly going off for hours at a time - without response - so no one leaves the building. 11 car parking spaces, is not enough for the population demographic now being housed. Despite repeated requests, no one in authority from Cornwall Housing ever visits. The residents want to know what can be done to make the place nice again, esp. given previous promises of extra funding. Cllr D Tudor Cornwall Council listened and pick up the points. She, together with Cllr Knill, agreed to meet on site with the resident Monday 2nd October 14:00 to get a first-hand appreciation of the current situation.

Permission in Principle application for the erection of up to one affordable dwelling, Land Adj To Wheal Bidden Farm Twelveheads Truro Cornwall TR4 8PQ

Original Comment

CPC is concerned that the site is not within a defined settlement and is seen as development in the open countryside.

CPC is acutely aware of the need for affordable housing within the Parish and is very supportive of proposals for affordable housing - including those on Rural Exception Sites - that comply with the NPPF, Cornwall Local Plan and our made NDP policies.

We are unable to support this application as it does not meet the definition in Annex 2 of the NPPF of

"affordable housing". The landlord will not be a Registered Social Landlord/Registered Provider, it is not part of a Build to Rent Scheme, nor is the property being constructed for discounted market sale - as the developer's intention to provide housing for a specified relative. Should the applicant proceed with the application CPC request that the application be amended to reflect the definition of affordable housing, and that Cornwall Council agree a planning obligation agreement with the applicant that will ensure that the property is offered for rent or sale, and continues to be offered for rent or sale, at a discount, to eligible households.

As design matters are reserved, we will comment when these points are proposed, but note that the proposed highway access should be enhanced as the current provision appears unsafe.
